## UPDATED PRIVACY POLICY

Should you purchase items from Hansa's Restaurant i.e private catering, take-away items, Hansa's Cookbooks, Hansa's Masala Tins, etc we will collect your name, contact information and billing address but will **not** document your credit/debit card information.

## WHAT DO WE DO WITH THE INFORMATION WE GATHER

We gather your personal information to ensure that we provide you with high quality customer service. We will also utilise your personal information to keep you updated with the latest Hansa's Events information, Cookery School updates, Reminders, etc.

## DO WE DISCLOSE YOUR PERSONAL DATA TO THIRD PARTIES?

The information provided by you will not be disclosed to any other third party, unless consent has been obtained by yourself prior, or unless otherwise required to do so by law.

Details we hold on file for Hansa's Restaurant bookings or Hansa's Cookery School enrolment, is only available to be viewed by **Hansa's proprietors and managers only**. Other than those entities highlighted above, we will not share details held on behalf of nominees to any other third party, unless permission has been obtained prior.
